A further exploration of the effect of metropolitan life on fashion and its development. A survey of the development of shopping in industrialized society.

A brief survey of the influence of sports, entertainment, theatre, film, photography and travel on fashionable styles, and their relation to the development of mass-produced and mass-marketed fashions.	
<i>Chapter Nine: Oppositional Dress</i>	179
Counter-cultural, sub-cultural and other 'deviant' forms of dress, and their development in industrialized society. The relationship of counter-cultural styles to political dissent.	
<i>Chapter Ten: Utopian Dress and Dress Reform</i>	208
A brief history of the nineteenth-century dress reform movement and of twentieth-century developments; and a survey of dress and fashion in utopian literature: the attempt to abolish fashion.	
<i>Chapter Eleven: Feminism and Fashion</i>	228
The feminist condemnation of fashion is rejected, and it is suggested that it is inappropriate to see fashion as a moral problem, or as evidence of inauthenticity, 'false consciousness' or subjection to false values. We should rather see it as an artistic and political means of expression, albeit an ambiguous one.
